

- a) There will be a Sub Committee known as Finance Sub Committee in charge of Finances and Accounts.
- d) The reports or recommendation of these Sub Committees would require the approval of the Board of Trustees and if unanimous will ordinarily be accepted.
- e) If any member of the Trust has any financial interest in any manner what-so-ever, he shall be deemed to have vacated the office of trustee.
- f) The Office Bearers except the Chairman, as mentioned in Section 4 and the members of the Sub Committees mentioned above, shall be elected annually by the Board of Trustees.
15. The Trust will constitute Advisory Committees one for each of the Schools being run and controlled by it, for advising and assisting the Trust in the management of the Schools. These Advisory Committees will consist of representatives of the Trust, Parents of the Students, Staff and the Students.
16. The Chairman is authorised to sign all documents, deeds etc. relating to the Trust on behalf of the Board of Trustees and all legal proceedings, Civil or Criminal may be instituted by or defended by the Chairman or Secretary of the Trust.
17. All properties moveable and immoveable Belonging to the Trust shall vest and deemed to have vested in, the Board of Trustees and any dealings with the said properties in any manner what-so-ever shall be in that capacity.
18. The Chairman of the Salwan Education Trust may raise funds for the benefit and in the interest of the Trust whether by mortgage of Trust Property or otherwise.
19. Any change in the Rules and Regulations of the Trust can be made by the Board of Trustees. But in case of acquisition or alienation of such other Society or Trust either partially or wholly, a special meeting of the Trust shall be called and the proposal shall be carried if approved by the 3/4th of the then existing Trustees.
20. In case of dissolution of the Trust, a special meeting of the Trustees shall be called and the proposal shall be considered. This proposal should be approved at least by 3/4th of the members present in the meeting. This proposal shall be laid before the Board at least one month after the passing of the resolution in a specially called meeting and shall take effect only if approved by 7/8th of the total number of the Trustees and thereupon it shall be dissolved forthwith or at the time agreed upon and all necessary steps shall be taken for the disposal and settlement of the property of the Trust. Its claims and liabilities according to the rules of the said Trust applicable thereto if any, then as the Trust is small and expedient, provided in the event of any dispute not resolvable by the 2/3rd members of the Trust, the adjustment of its affairs shall be referred to the Principal Court of original civil jurisdiction of the district in which the chief building of the Trust is situated and the Court shall make such order as the matter as it shall deem requisite provided that whenever Govt. is a member and/or a Contributor to or otherwise interested in the Trust, then the Trust shall not be dissolved without the consent of the Govt. of the State of registration.
21. If upon the dissolution of the Society registered under the Societies' Registration Act, there shall remain after the satisfaction of all its debts and liabilities any property whatsoever, the same shall not be paid to or distributed among the members of the said Society or any of them, but shall be given to some other Society, to be determined by the votes of not less than 3/5th of the members present personally or by proxy at the time of the dissolution or in default thereof by such Court as aforesaid.
22. Registered Office of the Trust will be situated in the province of Delhi at 10, Marina Arcade, Connaught Circus, New Delhi.
